STATEMENT OF SIGNIFICANCE 10.

Ord & Bateman Street Precinct, comprising a group of 18 one- and twostorey residences constructed from 1891 to 1903 in the Federation Bungalow and Federation Filigree styles, has cultural heritage significance for the following reasons:

the precinct is rare as an intact group of Federation period residences;

the early owners and developers of the precinct were prominent Fremantle businessmen Lionel Holdsworth (expiree, accountant and mercantile clerk) and Henry Dixson (tobacco merchant);

the precinct contributes to the Fremantle community's sense of place through its distinctive streetscape:

the houses between 20 and 24 Ord Street have strong landmark qualities as fine two-storey examples of Federation Filligree architecture, accentuated by their location above street level; and

the precinct contains a rare collection of fine Federation Filigree style residences.

The 2001 addition to 3 Bateman Street is of little significance. There are no intrusive elements.
