#### 10. STATEMENT OF SIGNIFICANCE

Pemberton Timber Mill Workers' Cottages Precinct, a complex of timber weatherboard clad cottages including related buildings, with corrugated iron roofs in the Federation and Inter-War Bungalow styles built for State Sawmills c.1913-1920 and c.1924-26, together with bungalows built c.1951, mill manager's house, teacher's house, former dining room, former boarding house and church, streets and rear lanes, open spaces, gardens and landscaping, has cultural heritage significance for the following reasons:

the historic precinct is rare as a large collection of relatively intact timber mill workers cottages including related buildings;

the historic precinct is a substantial collection of buildings, streetscapes, laneways, and a pair of rail tracks that collectively form a significant intact timber townscape;

the historic precinct was developed as an integral part of State Saw Mills' operations in the South-West from 1913-14 to 1961, and subsequently has continued as a mill workers' precinct under Hawker Siddeley and later Bunnings, (now Sotico), through the remainder of the twentieth century and into 2002;

the historic precinct is a large collection of simple well proportioned timber mill workers' cottages, a former dining room and a former boarding house, together with a mill manager's house and outbuildings in the Federation and Inter-War Bungalow styles, framed and clad in karri with iron roofs, whose collective visual impact is significant; and,

the historic precinct is valued by the community of Pemberton, the Shire of Manjimup and the wider community of Western Australia for social and cultural reasons, as evidenced by community concerns expressed in regard to its future, by its inclusion in the Municipal Heritage Inventory, and its inclusion on the National Trusts of Australia's list of endangered places in August 2002.

Generally, the hot water systems and aluminium-framed windows have little significance. The Uniting Church has not been individually assessed.
