10. STATEMENT OF SIGNIFICANCE

Donnybrook Railway Precinct, comprising goods shed, English Oak tree (*Quercus robur*), station master's house, five-ton crane, Stevenson screen, station building, packing sheds, through-line track and shunting loops, has cultural heritage significance for the following reasons:

the place is a good example of a collection of railway buildings that forms part of a significant townscape, which includes the Donnybrook Hotel and the Post Office;

the establishment of the historic precinct was a catalyst for the development of the Donnybrook township and district, which became a major centre in the apple industry in the South West, and enabled the quarrying and transport of Donnybrook sandstone, a feature of some major buildings in Western Australia;

the historic precinct was established in 1893, developing as a major junction on the South Western line, and provides evidence of the importance of the railway system in the development of regional Western Australia;

the station master's house is a rare remaining example of an 1890s residence of the type;

the various elements of the historic precinct are representative of the type of buildings and services considered appropriate for passenger and freight services at a major junction station in the South West in the first half of the twentieth century;

the historic precinct is rare as a relatively intact railway precinct located in the centre of a rural settlement; and,

the c.1893 English Oak (*Quercus robur*) is an important landmark, linking the station building and station master's house, with its natural beauty providing a contrast to the angular built features of the historic precinct.

The packing sheds (Sheds 1, 2 and 4) within the railway reserve are significant for their associations with the important local fruit growing industry, but are not aesthetically significant elements.

Landscaping elements from the 1990s are of little significance. The rotunda is of little significance. The ammonia condenser near Shed 4 is of little significance.
